At a Special Meeting of the Board of Education of Fresno Unified School District, held on June 27, 2019, there were present Board Members: Davis, Islas, Mills, Major Slatic, Thomas and President Cazares. Superintendent Nelson was also present. For the record, Board Member Islas arrived at 8:06 a.m.

President Cazares CONVENED the Special Board Meeting at 8:00 a.m. to discuss the following items on the agenda:

- 1. OPPORTUNITY for Public Disclosure and RATIFY the 2019-2022 Negotiated Collective Bargaining Agreement between Fresno Unified School District and Fresno Teachers Association**  
**RATIFIED as recommended**, in accordance with Government Code 3547.5, all major provisions of collective bargaining agreements are to be presented at a public meeting of the public-school employer before the employer enters into written agreement with an exclusive representative. Included in the Board binders is a copy of the Tentative Agreement (TA) between Fresno Unified School District and Fresno Teachers Association (FTA).
