For the record, Board members had comments/questions pertaining to agenda item A-7. A summary is as follows:

**Member Jonasson Rosas:** Requested clarity as to if the backlog of officers is resolved. Commented it is important first for schools to be supported. Requested clarity as to if the district has input in the interview process. Requested clarity as to if the district determines what constitutes overtime. Believes the agreements need to be tightened and state something similar to, "at the direction of Fresno Unified."

**Member Levine:** Thanked Amy Idsvoog for making time to discuss this item. Requested clarity as to if the addition of the new SRO was planned from the beginning. Commented on the report received pertaining to student perception of interactions with SROs and commented not comfortable supporting this item until numbers improved.

**President Islas:** Commented the information regarding the other districts was not clear. Commented on Fresno Unified paying 50% of cost and it is not divided equitably between the three districts. Commented on the cost of the vehicles. Shared concern about the impact/profiling of students of color and stated no student should be at a disadvantage. Requested to see cultural proficiency training and evidence it resolves concerns and is hesitant to invest until evidence is provided.

On a motion by Board Member Davis, seconded by Board Member Thomas, agenda item A-7 was approved by a vote of 5-2-0-0 as follows: AYES: Board Members: Cazares, Davis, Jonasson Rosas, Thomas, and Clerk Wittrup. NOES: Board President Islas and Board Member Levine.

# **B. CONFERENCE/DISCUSSION AGENDA**

# B-16, PRESENT and DISCUSS Bulldog Bound Partnership with Fresno State

Staff presented a new partnership with Fresno State to launch a program called Bulldog Bound. Bulldog Bound is Fresno State's guaranteed admissions program that will provide high school students from partnering school districts who meet the minimum California State University requirements a guaranteed spot after graduation.

For the record, Board members had comments/questions pertaining to agenda item B-16. A summary is as follows:

**Member Thomas:** Requested clarity as to if students have already been opted in. Requested to see this promoted at the seventh and eighth grades to show students what will be available, something to look forward to. Recommended all students be treated as equal. Requested information pertaining to the demographics of students for Uni-track and dual enrollment.

**Member Levine:** Echoed the request of Trustee Thomas as to messaging to seventh and eighth grade students. Proposed students opted in to the CALKIDS program when opted into the Bulldog Bound Program, asked if this could be built into the system. Commented on numbers of students who have signed up for CALKIDS, underscored the importance of the district getting the word to students.

**Member Cazares:** Thanked Fresno State staff for attending, asked Senior Recruitment Officer Jesse Farias to introduce himself. Commented on the need to be creative with opportunities to promote the program. Commented the field trip to the Fresno State Farm is a good opportunity to talk to students about the Bulldog Bound program. Suggested the Fresno State mascot attend district school sites to

encourage participation in the Bulldog Bound program. Requested the message be pushed out especially to ninth graders via Parent Square. Suggested Fresno Unified CTE pathway students be partnered with similar pathways at Fresno State.

**Member Davis:** Asked if there could be a fall or spring field trip for parents.

**Member Jonasson Rosas:** Commented on possible misuse of Fresno State identity cards. Asked if there was a way to tie the Steve Scholars program to the Bulldog Bound program. Requested clarity on Uni-track and dual enrollment, asked if Uni-track credits transfer from community college to university. Requested district staff to help counseling staff build and strengthen relationships with Fresno State in order to provide a warmer handoff of students.

**President Islas:** Shared excitement for this program and requested staff to be sure to message course opportunities. Commented on the need to create infrastructure to keep students in Fresno State, provided suggestions as follows: transportation, affordable housing, childcare, help remove barriers to keep students in school, engaging parents in culturally competent ways, underscored the importance of engaging parents, and mentorship opportunities. Commented on the desire to see the program grow and see it be mutually beneficial.

Jeremy Ward, Nancy Witrado, Phoung Yang, and Jesse Farias were available to provide clarity.
