#### MINUTES - BOARD OF EDUCATION REGULAR MEETING

Fresno, California November 01, 2023

Fresno Unified School District, Education Center, 2309 Tulare Street, Fresno, CA 93721.

At a Regular Meeting of the Board of Education of Fresno Unified School District, held on November 01, 2023, there were present Board Members Cazares, Davis, Jonasson Rosas, Levine, Clerk Wittrup, and Board President Islas. Superintendent Robert G. Nelson, Ed.D. was also present.

For the record, Board Member Thomas participated from the teleconference location as follows: 18276 Sorrento Street, Detroit, Michigan 48235, open to the public; and, pursuant to Government Code Section 54953 (B)(2), all action taken during this teleconferenced meeting was by roll call vote.

Board President Islas CONVENED the Regular Board Meeting at 4:33 p.m.

For the record, Board Member Levine arrived at 4:36 p.m.

For the record, it came to the district's attention two items needed to be added to the Conference and Discussion section of the agenda for the November 01, 2023, Board of Education meeting.

For the record, the motion is recorded as follows:

Shall the Board add items to its open session agenda titled:

Consideration and Action to ratify the Tentative Agreement between the district and Fresno Teachers Association, including issuance of AB1200 information.

Appeal of Confidential Administrative Determination, Heidi Sagasar.

On or about May 04, 2023, Ms. Sagasar filed a personnel complaint against the Executive Director of Health Services. After investigation, a Notice of Determination was provided to Ms. Sagasar indicating the allegations were not sustained. On August 09, 2023, Ms. Sagasar submitted an appeal of the determination for Board consideration.

In accordance with BP/AR 4030, a three-trustee subcommittee was appointed to review the appeal of administrative determination. In addition to myself, members of the subcommittee included Board Clerk Susan Wittrup and Board Member Andy Levine. The subcommittee met on Tuesday, October 31, 2023, and reviewed the appeal and related documents.

After review and full consideration of Ms. Sagaser's appeal, the subcommittee recommends the Board direct Human Resources to initiate a supplemental investigation regarding the complaint.

 Ms. Sagasar: Contends the investigation was not neutral and requested a new consolidated investigation facilitated by a neutral, impartial investigator.

Ms. Kolb: Requested the Board open a new and independent investigation of the age discrimination complaint she filed with Fresno Unified School District.

  coverage for life upon retirement, substantive movement towards class size
  reduction, and charts a clear path forward for continued collaboration in hopes of
  avoiding this situation in the future.
- Shared this was incredibly tough work and there are so many people to thank for avoiding a strike and working towards amazing things on behalf of our students. Thank you to our Board of Education Trustees. Without this Board, we could never have come to this "historic" agreement. Thank you to our bargaining team. I thank every staff member that came to the table, or even in support of the table, throughout this process. I especially thank:

Additionally, pursuant to Title VII of the Civil Rights Act of 1964, district programs and activities shall be free from any unlawful language discrimination, which falls under the class of national origin discrimination. Language discrimination occurs when a person is treated differently because of their native language or other characteristics of their speech, including their accent, vocabulary, and/or syntax.
